1. The Seller agrees to sell and Buyer agrees to buy the following vehicle (the "Vehicle") on the terms of this agreement:

4. The Seller warrants that the Seller is the legal owner and has the right to sell the Vehicle, and that the Vehicle's odometer reading is substantially accurate.
5. The Seller warrants that the Vehicle is free of any securities (encumbrances) (e.g. money owing to a finance company).
6. Should the Vehicle be damaged prior to the Transfer Date, the Buyer has the right to cancel this agreement and receive full repayment of any deposit.
7. The Buyer acknowledges that the Buyer has examined the Vehicle and agrees to purchase and accept the Vehicle on an 'as-is, where-is' basis with no warranties whatsoever, except as stated in clause 10.
8. The Buyer understands that risk (and therefore the responsibility for insurance) and title to the Vehicle will pass to the Buyer with effect from the Transfer Date.
9. The Buyer and Seller further agree that this agreement is the whole of the agreement between them and supersedes any prior agreement or understanding between them.
10. The Seller will return the Buyer's deposit in full within three (3) days should the conditions of this agreement not be met or waived by the Buyer.
11. The Seller makes no other warranties or representations regarding the condition of the Vehicle except as expressly stipulated in this agreement.
