What should I do?

Be cautious. If you suspect a reading has been entered incorrectly ask the seller to provide evidence (e.g. last WOF test sheet) to the NZTA immediately so they can correct the reading. The NZTA can be contacted on **0800 108 809**. Wait, then get a **recheck** to verify the correction.

If you suspect the odometer has been tampered with we suggest you get a [Mechanical Check](#) or have the vehicle checked by a specialised odometer inspector such as [odocheck.co.nz](#).

If the odometer has been reset (i.e. has gone 'around-the-clock' or has been replaced) you need to factor in the true mileage before you purchase.




